IADB's funding of AH&FS Programmes

- Basic information about IADB:
 - LAC Regional Bank since 1959: 50 years!!
 - 48 member countries (only 26 borrowers)
 - More than USD\$165.000 millions in loans since 1959
 - Current loan portfolio is over USD\$ 50,000 millions in more than 600 development projects and programmes
 - 2008: Loans approved for more than USD\$10,000 millions
 - Strategic area of intervention: Regional economic integration



IADB's funding of AH&FS Programmes

- Main financial source for AH&FS programmes in most LAC countries
- Between 1968 – 2008
 - More than US\$ 650 millions in AH&FS projects and programmes
 - Almost US\$13 millions in grants (technical cooperation and assistance)

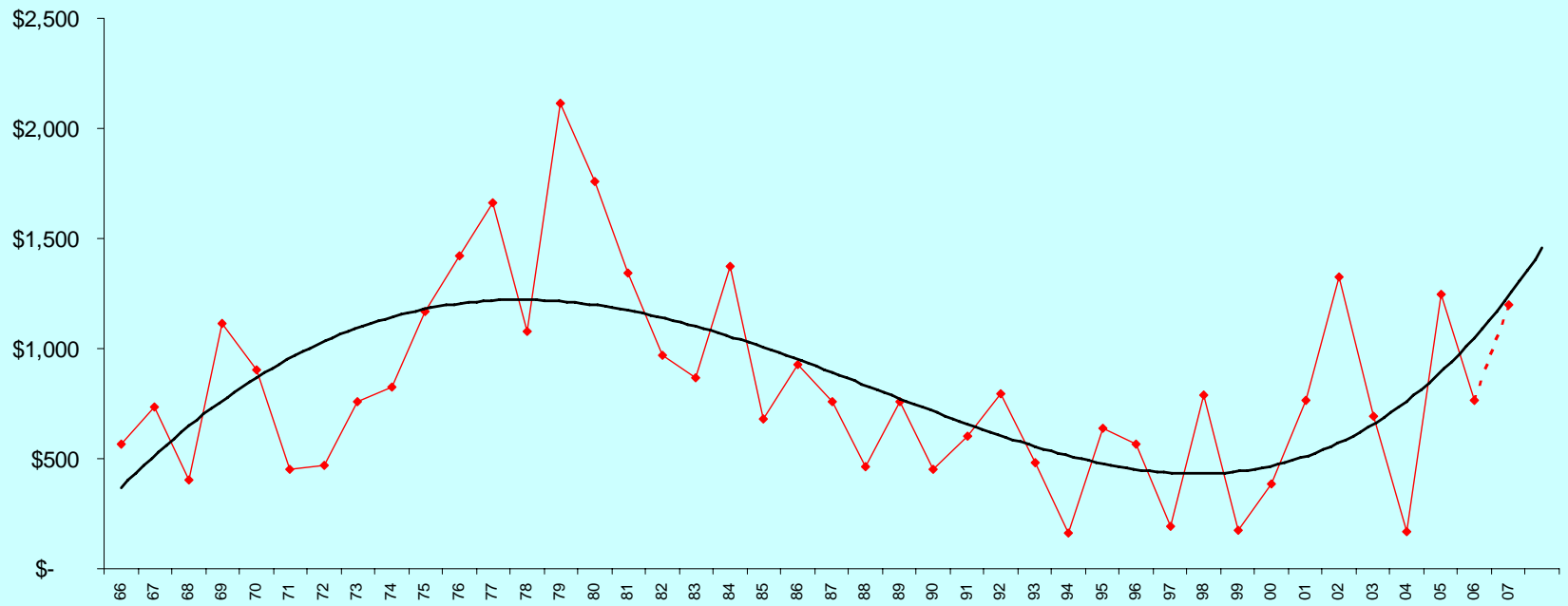

Memorandum of Understanding IADB - OIE

- Signed in July 2008
- Objective: To support and promote Animal Health Systems in Latin America and the Caribbean
- Exchange of information and consultation
- Areas of Cooperation:
 - Capacity building of National Veterinary and Sanitary Services
 - Combating animal diseases and improving the safety of food of animal origin
 - Promoting LAC countries in setting international standards
 - **Encouraging the utilization and application of international guidelines and standards of quality evaluation of veterinary services (PVS Tool)**



Memorandum of Understanding IADB - OIE

- Encouraging the utilization of the PVS tool - developed by the OIE- for National Veterinary Services improvement and strengthening (Building institutional capacity)



IADB's main financial instruments to support the implementation of Animal Identification and Traceability activities

- Investment Loans
- Conditional Credit Line for Investment Projects (CCLIP)
 - Technical Cooperations and Regional Public Goods (Grants)
 - Multilateral Investment Fund projects (MIF - Grants)
